BCSFAZINES:

Goal: To preserve two copies of each issue in filing cabinet (donated by Eugene James), each issue double—set in a separate envelope, clearly labelled, and in date order. One copy never to leave premises, other copy available for loan or display. In addition, to catalogue contents and contributors of entire run, ultimately to be on file in searchable database.

#1 to #13:

- STATUS: NONE.

#14 to #110:

- STATUS: STRONG. Double copy sets madeup (a few exceptions) with extras left over.
- I selected best condition copies for archives.
- -! also set aside some extras for future fan room displays at Cons.
- Of the remainder, Yaugn Bode cover issue, William Gibson cover issue, and William Gibson interior art issues probably of particular value. To auction or sell?

- STATUS: NONE. (2 or 3 exceptions: single copies)

- Adding in extras on hand, results in 22 issues missing, 12 single copy, 44 double copy.

CONCLUSIONS:

Archives are missing 44 issues. Some of these may be in the other half of the archives not yet transferred. If not, my own collection is a complete set except for #1 & #7, so I can provide photocopies for 42 of the 44. Old time members may possibly provide photocopies of #1 & #7.

FANZINES:

Goal: to organize and catalogue zines for research, display, and ultimately —— with appropriate safeguards —— for lending to members.

in general, a bunch of zines from the '70s & '80s. Some are slowly turning brown with age. About ten were turning green and dissolving — these were trashed to prevent infecting others with mold? Martian slime? Whatever it was....

The bulk of the material is a wide assortment of Canadian, British, American & Australian zines. These are not in sets or runs, but average one or two sample Issues only, with some exceptions.

The remainder are club tradezines such as Pulsar, Westwind, Dataphile, Texas Sf Inquirer, etc. I had expected complete runs for the (approx) ten year period between Gerald becoming Archivist and my becoming editor, but in fact the material is spotty and far less than I had anticipated. For example, only 16 issues of Ottawa SF Statement (during my 6 years as editor I received at least 50, I think...).

NOTABLE FANZINE ITEMS IN ARCHIVES:

- 6° issues of Susan Wood's perzine AMOR, donated by Vera Johnson.
- 28 issues of VANAPA (out of total run of 35), donated by Fran Skene?
- 4 issues of BC APA.
- 4 Issues of THE SFA DIGEST (splinter BCSFAzine by Jim Welch.)
- 17 issues of NEOLOGY (out of Edmonton club).
- 20 Issues of Harry Warner Jr. FAPA contributions.
- 11 issues of OSFIC NEWSLETTER (now defunct Ontario club).
- 3 issues of THE CENTRAL GANGLION (early Garth Spencer newszine).
- 6 issues of THE MAPLE LEAF RAG (Garth's Casper winning newszine).

CONCLUSIONS:

Perhaps the second half of the archives not yet transferred contains more zines. At any rate I have kept all tradezines received from 1989 to date. I will sort and collate with the above. Expect a simple catalogue listing issues & dates within a year. A more detailed catalogue listing contents and contributors will have to wait, as cataloguing BCSFAzine is my first priority.

I intend to make it possible to easily access all the zines in possession of the club, so that none remain "buried" and impossible of access.

Some of these zines I hope to display at the upcoming V-Con 21.

Y-CON MATERIAL:

Goal: to maintain a file of all surviving material, each convention in a separate folder, in archive filing cabinet. For ease of research, to catalogue said items.

THE METERS OF THE CONTRACT OF THE PROPERTY OF

STATUS: MEAGRE. Preliminary look reveals only 6 program books, some flyers and progress reports, assorted letters of the "sorry, can't make it" variety, and various 'stuff'. I will investigate material more thoroughly soon. In general though, very disappointing. Maybe more will show up when second half of archives transferred.

CONCLUSIONS:

My own collection of V-Con material is far more comprehensive. (For example, I have originals or photocopies of all V-Con program books except 2nd con.) At this point, my collection is the definitive one. I propose to collate archive material with my (more extensive) collection and loan said items to archives for research purposes, ultimately to donate.

ASSORTED OTHER CONVENTIONS:

Goal: to maintain for research & display purposes.

Pile of stuff includes some Worldcon program books & progress reports, plus same for other cons, like British Eastercons, Novacons, etc. I believe most of this material was donated by Fran Skene & Vera Johnson.

CONCLUSIONS:

Low priority. I will sort & catalogue eventually.

Items may be of use to V-Con Committees looking for ideas.

ITEMS LOOKED FOR BUT NOT PRESENT:

COMMENT: None of the above present. However, I have copies of UBC SF newsletters mailed to me as member at the time, and I can provide photocopies.

- (from Fran Skene) "4 boxes of material."

COMMENT: #4 newsletter not present. However, many of the fanzines & other con material in the archives probably derive from the above donation by Fran.

FROM BCSFAZINE #89 (November 1980):

(from Gerald Boyko)

- "Fandom Directory 1980.
- Scientifriction 11 fanzine."

COMMENT: not present. Gerald also talks about: "When A.E. van Vogt was GoH at Y-Con 6 there was a "Comments Book" in which convention goers were invited to write their comments... That

comments book should be in the archives. It is probably buried and forgotten in some corner of someone's home, so let's everybody search and see if it can be found...." This book is now in the possession of Gerald, and I agree, it should be in the archives.

FROM BCSFAZINE #90 (December 1980):

- (Re death of Susan Wood on Nov 12): "Gerald Boyko reports that the BCSFA archives will be receiving a donation of fanzines from Susan Wood's collection. When he receives the collection, he will report in more detail."

COMMENT: As far as I am aware, no list of items donated was published in BCSFAzine. Some of the zines in the archives may derive from this donation. However, the only items BY Susan are the issues of AMOR donated by Vera Johnson. If the donation from Susan Wood's estate included any zines BY Susan, they are not present in the material so far transferred.

FROM BCSFAZINE #93 (March 1981): (From Executive Meeting Minutes):

"Gerald's archivist report, #5, unpublished, was discussed, as well as Jo-Anne's letter to him. re Susan Wood's collection. 'Nuff said."

COMMENT: Arrigh! What was in the donation from Susan's collection? And what was at issue re Jo-Anne's letter? Was the donation dispersed? What was discussed? Arrigh! JO-ANNE HELPED SUSAN'S MOTHER SON SUSAN'S POSSESSIONS FOR 10 days Susan Wood ZINEF COLLECTION WENE DONATED TO ANCHIVE COUNTESY FROM BCSFAZINE #154 (March 1985); OF SUSAN'S MOTHER, AS CHOSEW BY JO-ANNE, (describing notable items in archives):

"The only mint set of our club T-shirts in existence."

(Comment: Not present. Gerald told Clint they were stored in Garbage bags 'at home of a member of the executive' and thrown out by accident?

- "ENERGUMEN by Susan Wood...."

(Comment: Not present. One copy or a set? Part of her estate's donation?"

"INCOMPLETE TERRY CARR' a fanthology of some of his best fan writing."

(Comment: Not present. However, I bought a copy at Ditto 8 & can make it available.)

- "WARHOON original issues from 1950's & 1960's of what is generally considered one of the best fanzines ever."

(Comment: Not Present, Darn!... I acquired one copy at Ditto 8 & can loan on occasion.)

"FANTARAMA by Vaugn Fraser."

(Comment: 2 copies of 1 issue present. Were there others?)

- "THE ENCHANTED DUPLICATOR, a fan classic originally written in 1954 by Walt Willis & Bob Shaw, reprinted continuously since then."

(Comment: Not present. Unless he's referring to the program book of a stage production.)

- "A HISTORY OF THE HUGO, NEBULA & INT'L FANYTASY AWARDS by Donald Framson." (Comment: Not Present, Unless buried in con material, Will check.)

- "ALL OUR YESTERDAYS by Harry Warner Jr. Book with photos on 1940s fan history."

(Comment: Not present, I own a photocopy however, & can always loan.)

- Gerald also writes: "Some things are on indefinite loan to the archives from my personal collection" but does not state what they are. So presumably any or all of the items listed in #154 could well be his.



Based on the above listing of items held in the archives in the past, the portion transferred to me appears to be very incomplete. However, there still remains a second batch yet to come, and hopefully it will contain the bulk of the material anticipated, particularly club records and the like.

Overall I am surprised at how little material there is. On the other hand, this makes it easier for me to put it in order and store.

To be fair to Gerald, much of the material was already in order. BCSFAzines were in order by date, and fanzines generally were arranged by country and by name of editor. The rest of the stuff is easy enough to sort.

As I understand matters, once the transfer is complete, I will be the new archivist. This I am prepared to be for the forseeable future, until such time as the archive is passed on to someone else, or placed In a 'permanent' home such as a university or a library. (I state for the record, however, that I would like to hang on to my 'indefinite' loan V-Con material until such time as I have completed writing up the history of V-Cons, but ultimately I will be willing to donate.)

The physical Infrastructure of the archive is one filing cabinet (donated by Eugene James) in which I will keep the BCSFAzines, V-Con material & club records, and assorted kitchen cupboards & livingroom shelves where I will keep the rest of the stuff (mostly fanzines.)

How to differentiate between my zine collection & the club's? I propose to either stick coloured dots on the club's zines (or mine), or have a stamp made up saying something like "Property of the BCSFA/WCSFA Archives."

I am quite keen to be the new archivist, mainly because I want to use it for research when working on my club history, or writing articles for BCSFAzine and/or FHAPA (The Fan Historical Amateur Press Association.)

To that end I intend to convert it into a working tool for research in which every item is catalogued and listed as to location. This will make it easy to access any item virtually in an instance. This of course will also make the archives much easier of access for purposes of selecting items for display at V-Cons or club meetings, or for loaning to interested members.

I caution that it will take me awhile to convert the archives into a usable tool for said purposes. I will keep you informed. First to be ready will probably be the catalogue for the BCSFAzines. Next will be a simple listing of zines, followed by a detailed catalogue at a later time. And at some point, a catalogue of Y-Con Material. Club records will also receive priority treatment. And of course, eventually there will be a catalogue of the catalogues! (That's a joke, I think....)
